

TOWN OF SALTCOATS

BYLAW NO. 03-2025

A BYLAW OF THE TOWN OF SALTCOATS TO FIX THE RATES TO BE CHARGED FOR THE USE AND DISPOSAL OF RECYCLABLES AND WASTE WITHIN THE MUNICIPALITY.

THE COUNCIL OF THE TOWN OF SALTCOATS, IN THE PROVINCE OF SASKATCHEWAN, ENACTS AS FOLLOWS:

1. TITLE

- a. This bylaw may be cited as the "Recycle and Waste Rates Bylaw".

2. PURPOSE

- a. The purpose of the Bylaw is to govern the rates charged for recycle and waste the Town of Saltcoats.

3. DEFINITIONS

- a. "Town" means the Town of Saltcoats, in the Province of Saskatchewan.
- b. "Customer" means the person(s), organization, corporation, etc. responsible for the payment of charges for utility services supplied by the Town.

4. RECYCLE

- a. The charges to be paid by the customer who owns or occupies a premise that is eligible for collection and disposal of recycled material shall be those set out in the attached schedule marked as "A".
- b. The recycle charge shall be payable in every case whether or not any customer material is collected or disposed of by the Town.

5. WASTE

- a. The charges to be paid by the customer who owns or occupies a premise that is eligible for collection and disposal of waste shall be those set out in the attached schedule marked as "B".
- b. The waste charge shall be payable in every case whether or not any customer waste is collected by the Town.

6. BILLING

- a. Customers shall be set up on accounts and billed for periods covering three successive months, according to the applicable rate on each schedule.
- b. Customers set up on or removed from an account in the middle of any given three-month billing cycle will have charges pro-rated for each day the services are provided.
- c. Billing shall be rendered on or before the fifteenth day of the month following each three-month period.

7. PENALTIES ON UNPAID CHARGES

- a. A penalty of two percent (2%) per month shall be charged to all utility accounts that remain unpaid after 30 days.
- b. Unpaid account balances after 90 days will be reviewed by administration and action taken pursuant to applicable Town bylaws or policies.

8. REPEAL

Bylaw 06-2024 are hereby repealed.

9. The rates contained in this bylaw shall come into force and take effect on July 1, 2025
